





Postal Service Of The United States

Domestic Rates of Postage. All mailable matter to points in the United States, Canada, Mexico, Cuba, Porto Rico, Hawaii, Guam and the Philippines, is divided into four classes under the following regulations:

First Class Matter. This class includes letters, postal cards, post cards and anything sealed or otherwise closed against inspection, or anything containing writing not allowed on mail matter of other classifications. Rates of letter postage, two cents per ounce or fraction thereof.

Second Class Matter. This class includes all newspapers, periodicals, or matter exclusively in print and regularly issued at stated intervals as frequently as four times a year.

Rates of postage on transient papers, magazines or periodicals, one cent for each four ounces or fraction thereof.

Third Class Matter. Mail matter of this class includes printed books, pamphlets, engravings, circulars in print etc. and the rate on such matter is one cent for each two ounces or fraction thereof.

Fourth Class Matter. See Parcel Post rates.

Special Delivery Stamps. Special delivery stamps, costing 10 cents each may be attached to all classes of mail and insures the immediate delivery by special messenger. The delivery, at carrier offices extends to the limits of the carriers route. At non-carrier offices it extends to one mile from the postoffice. Postmasters are not obliged to deliver beyond these limits, and all mail matter with special delivery stamps addressed for those living beyond the mile limit will be delivered in the regular way.

All postage must be prepaid and the special delivery stamp does not count as postage.

The Registry System. All First Class matter may be registered upon payment of a fee of 10 cents in addition to the regular postage. Each letter or package must bear the name and address of the sender and if desired a receipt will be returned from the one to whom addressed.

The Money Order System. Domestic money orders are issued by money order offices for any amount up to \$100. (See page 20 for sample application blank, fees, etc.)

Stamped Envelopes. Embossed stamped envelopes and newspaper wrappers of several denominations, sizes and colors are kept on sale at this office at a small advance on the postage rate.

Stamps cut from stamped envelopes are valueless and must not be used for postage. Stamp Books. The most convenient way to carry stamps is in the stamp book. We have them in books of 12, 24 and 48, 2 cent stamps; 24 and 96, 1 cent stamps; 24, 2 cent stamps and 24, 1 cent stamps combined.

#### Money Order System

Advantages of the System... The postal money order system offers to the public a safe, cheap and convenient method of making remittances by mail. Money can be sent without danger of loss at low rates to all parts of the United States and its possessions, as well as foreign countries by means of money orders. It is recommended that postal money orders be used whenever available instead of cash for remittances by mail and that when money orders are not available the money be sent by registered mail. quires the transaction of money order business at all post-offices where practicable. Postmasters are not required to transact money order business on Sunday.

Application for Money Orders, A money order is obtained by filling in an application form at the post office and presenting it at the money order window of the postoffice or one of its stations. Money orders are issued for any desired amount from 1 cent to one hundred dollars and when a larger sum than one hundred dollars is to be sent additional orders may be obtained. There is no limit to the number of money orders which may be sent by one remitter in one day to the same person. If the applicant for a money order resides on a rural route application may be made through the rural carrier, who will furnish the necessary forms, and must give a receipt for the amount.

International Money Orders. . . At all of the larger postoffices and at many of the smaller ones international money orders may be obtained payable in almost any part of the world.

Fees for money orders payable in the United States (which includes Hawaii and Porto Rico) and its possessions, comprising the Canal Zone (Isthmus of Panama.) Guam, the Philippines, and Tutuila, Samoa also for orders payable in Bermuda, British Guiana, British Honduras, Canada, Cuba. Mexico, Newfoundland, at the United States Postal Agency at Shanghai (China) in the Bahama Islands and in certain other islands in the West Indies. See page 48.

A money order drawn in favor of a person residing on a rural route may be paid through the carrier if entrusted to him for collection, with a written request addressed to the postmaster that payment be so made.

Repayment...A domestic order may be repaid at the office of issue within one year from the last day of the month of its issue. Repayment of the amount of an international order may also be effected after the consent of the country drawn on has been obtained.

Identification... The persons presenting a money order for payment or making inquiry relative to a money order, will, if unknown, be required to prove his identity, before payment will be made or information concerning the money order will be given.

Indorsements. More than one indorsement on a money order is prohibited by law, but additional signatures may be affixed for the purpose of identifying the payee or indorsee, or of guaranteeing his signature.

Invalid Orders.. A domestic order which has not been paid within one year from the last day of the month of its issue is invalid, but the owner may secure payment of the amount by making application to the Postoffice Department through the postmaster at any money order office.

Lost Orders. When a domestic money order has been lost, the owner may, upon application through either the office at which the original was issued or the office on which it was drawn, obtain, without charge, a duplicate to be issued in its stead within one year from the last day of the month of issue.

Postal Savings...An act of Congress approved June 25, 1910, provided for the establishment of Postal Savings Depositaries in all parts of the country, thus enabling all persons of the age of 10 or over to open an account by making an initial deposit of One Dollar or any multiple of it.

A postal saving depositor may have an account amounting to \$1000 upon which

interest will be paid.

When the deposits reach the sum of twenty dollars, they may be exchanged for a United States Bond of the denomination of twenty dollars, bearing interest at the rate of 2½% payable semi-annually.

Parcel Post System. The Parcel Post System was authorized by an act of Congress, approved August 24, 1912, and became effective Jan. 1, 1913. By this act all fourth class matter is placed under newly established rules and is extended to embrace farm and factory products and all mailable matter not included by law in either the first, second or third class.

Mailable Matter. Harmful articles, which from their form or nature might, unless properly secured, distroy, deface or otherwise damage the contents of the mail bag or harm the person of any postal employe, may be transmitted in the mail only when packed in accordance with the postal laws and regulations.

Butter, lard and perishable articles, such as fish, fresh meats, dressed fowls, vegetables, fruits, berries and articles of similar nature which decay quickly when so packed as to prevent damage to other mail matter, will be accepted for local delivery, that is, for delivery to be made in the same town as that in which the sender lives, or in its suburbs, reached by rural free delivery.

Butter, lard, or any oily or greasy substance intended for delivery at offices beyond the first zone must be packed in accordance with regulations, which regulations may be learned by inquiry at the Postoffice.

Eggs will be accepted for delivery when so packed as to prevent damage to other mail if broken. If properly packed there is very little danger of breakage. The container must be plainly marked "Eggs"

Preparation For Mailing. Parcel must be prepared for mailing in such manner that the contents may be easily examined and each parcel must bear the name and address of the sender preceded by the word "From"

Parcels containing perishable matter must be marked "Perishable" and fragile parcels must be marked "Fragile".

Limit Of Weight And Size. Parcels weighing up to 50 lbs and not measuring more than 84 inches in length and girth combined may be mailed in the first and second zones. No more than 20 lbs. may be sent to the other zones. (See following pages for rates.)

Insurance Of Parcels. A mailable parcel on which postage is fully prepaid may be insured against loss in an amount equivalent to its actual value, but not to exceed \$5 on payment of a fee of 3 cents and in amount not to exceed \$25 on payment of a fee of 5 cents and not to exceed \$50 on payment of a fee of 5 cents and not to exceed \$50 on payment of a fee of 10 cents

#### Amendments To Parcel Post Regulations

Parcel Post Matter Mailed in Glass Bottles. When in glass bottles, the quantity must not exceed sixteen ounces, liquid measure. The bottle must be very strong and must be inclosed in a block or tube of metal, wood, papier-mache or similar material, and there must be provided between the bottle and the block or tube a cushion of cotton, felt or other absorbent. The block or tube, if of wood, must be at least three-sixteenths of an inch thick in its thinnest part; if of papier-mache or similar material, it must be at least one-eighth of an inch thick for bottles holding two ounces or less, and at least five thirtyseconds of an inch thick for bottles holding more than two ounces. The block or tube must be rendered water-tight by an application of paraffine or other suitable substance.

Special Delivery Parcels. A mailable parcel will be accorded the usual special delivery service when a special delivery stamp or ten cents in ordinary stamps are affixed thereto in addition to the parcel post postage. When ordinary stamps are used the words "Special Delivery" must be placed on the wrapper.

- "C. O. D." Feature Effective July 1, 1913. The sender of a mailable parcel on which the postage is fully prepaid may have the price of the articles and the charges thereon collected from the addressee on payment of a fee of ten cents in parcel post stamps affixed, provided the amount to be collected does not exceed \$100. Such a parcel will be insured against loss, without additional charge, in an amount equivalent to its actual value, but not to exceed \$50.
- The sender of a collect on delivery (C. O. D.) parcel will be given a receipt showing the office and date of mailing, the number of the parcel, and the amount due him.
- 3. A C. O. D. parcel will be accepted for mailing only at a money-order office and when addressed to a money-order office. The postmaster at the mailing office will be held responsible for the postage required for the return of a parcel addressed to a non-money-order office.
- 4. The C. O. D. tag must show the amount due the sender, the money order fee necessary to make the remittance, and the total amount to be collected. It should be securely attached to the parcel, which should be numbered to correspond with the tag, stamped, C. O. D., and the charges to be collected plainly written thereon. The parcel will be treated as ordinary mail until it reaches the office of address, where on payment of all charges, it will be delivered to the addressee, or, unless otherwise directed by the addressee. to the person, firm or corporation in whose care it is addressed, or to any responsible person to whom the addressee's

- 5. A receipt signed by a person other than the addressee must show the name of the addressee as well as that of the person signing it. A signature made by mark (X) must be attested by a reputable witness.
- 6. When a C. O. D. parcel is received without the tag attached, the charges shown on the parcel must be collected and the prescribed receipt obtained from the addressee.
- 7. An employee must receipt for the total number of parcels given for delivery. This receipt will be surrendered to him either on the return of the parcels or the receipted tags and the total amount to be collected.
- 8. The receipted tag will be considered as the addressee's application for a money order for the amount due the sender. A money order will then be issued, stamped C. O. D., and mailed to the sender in a penalty envelope by the postmaster. who will enter on the tag the number of the money order, the amount and date of issue, and file it with other money-order applications. No return receipt will be furnished the sender, as the money order serves that purpose.
- 9. The addressee will not be permitted to examine the contents of a C. O. D. parcel until it has been receipted for and all charges paid. A parcel may be refused when it is tendered for delivery, but after delivery has been effected it can not be returned on account of dissatisfaction with the contents of the amount collected.

10. A parcel may be forwarded without the payment of an additional C. O. D. fee. When so forwarded a duplicate receipt tag should be filed showing the office to which it is forwarded.

11. The records of C. O. D. parcels must be preserved at the mailing office for one year and at the delivery office for

three years.

12. The Department will not be responsible for errors made by senders in stating the collection charges or for any misunderstanding between senders and addressees regarding the character or contents of parcels.

Parcels Weighing Four Ounces or Less May Be Deposited in Collection Boxes. Parcels weighing more than four ounces must be mailed at a post office, branch post office named or lettered station, or such numbered stations as may be designated by the postmaster, or delivered to a rural or other carrier authorized to receive such matter. Parcels weighing four ounces or less may be mailed in the same manner as matter of other classes.

#### N. Y., N. H. & H. R. R. TRAINS
